INTRODUCTION

The consultant will provide senior technical assistance for the development of green-grey Infrastructure Investments as shown:

 - People
- 2. Resilience options identification and appraisal
 - 2.1 Nature Based Solution "NbS" investment options assessment
 - 2.2 Capex / opex / climate sensitive O&M investment options assessment
 - 2.3 Resilience options investment proposal
- 3. Transaction Advisory Support.
 - 1.1 Structure the transactions climate risks and allocate these risks in line with the transactions structure
 - 1.2 Support to integrate climate resilience options into project design
