# 1. Background

# 1.1. Introduction to this Call for Partnership

The Global Center on Adaptation (GCA) invites registered non-profit organizations (including local and international non-government organizations, community-based organizations, universities, companies limited by guarantee) to submit concept notes for the development and delivery of a Climate Resilient Water Services Masterclass in various countries across Africa and South Asia.

# 1.2. Introduction to the Global Center of Adaptation

The Global Center on Adaptation (GCA) is an international organization that works as a solutions broker to catalyze action and support for adaptation solutions, from the international to the local, in partnership with the public and private sector, to ensure we learn from each other and work together for a climate resilient future. Adapting to impacts of climate change provides a "win-win" for livelihoods, food security, water supply, health, security, and economic growth. The work of GCA elevates the visibility and political importance of climate adaptation and facilitates solutions, such as smarter investments, new technologies and better planning to become more resilient to climate related threats. GCA is a rapidly growing organization with offices in Europe, Africa, and South Asia. GCA's ambitious 2020-2025 business plan and strategy have three pillars:

- Programs: Food Security; Using Nature for more resilient infrastructure; Water for Urban Growth and Resilience; Climate Finance; Youth Leadership.
- Knowledge: Building adaptation knowledge globally through cutting edge products such as the State and Trends in Adaptation Report and the Adaptation Knowledge Portal.
- Advocacy and Awareness: Formulating policy messages to move the global, regional, and local adaptation agendas forward.

# 2. Climate-resilient Water Services (CRWS) Masterclass Project

# 2.1. Context & Overview

- Water lies at the core of sustainable development, playing a vital role in both socio-economic
  development and ecosystem health. It is central to societal growth and is closely tied to the delivery
  of nearly all the United Nations' Sustainable Development goals. Water drives the supply and
  preservation of a wide range of ecosystem services, benefiting both people and nature. Given its
  cross-cutting and foundational nature, water is crucial for climate adaptation, bridging the climate
  system, human society, and the environment.
- African countries face the challenge of recurring floods and droughts driven by climate change, which significantly impacts access to water services. Recurring floods disrupt countries' capacity to provide adequate water and sanitation services.
- Climate change adds pressure to already strained water supply systems, posing a threat to achieving universal access to water. Access to potable water and sanitation services in most African countries is currently less than 50%, with even lower access in rural areas. Although urban populations in countries like Kenya, Cote d'Ivoire, and Namibia benefit from improved water services, most of the rural population have limited access to equivalent levels of service. Significant disparities exist across countries and climate change further exacerbates the challenges to provide safe water and sanitation services to both rural and urban populations.
- The impacts of climate change on water resources in Africa are already evident; they create
  complex development challenges for communities, ecosystem integrity, and governments. The
  growing frequency and intensity of wet and dry events, coupled with variable precipitation due to
  climate change, are impacting the quantity, quality, timing, and distribution of water across
  landscapes. Transboundary river basins face additional complexities, as collaborative
  management becomes crucial but challenging.
- Strengthening climate adaptation capacity is essential to establishing resilient watersheds, building resilience of water services, ensuring water security under diverse climate scenarios, and supporting social and economic development. Integrating climate change impacts and risks into watershed management, planning, and implementation – through both grey and nature-based



solutions - offers significant opportunities for enhancing ecosystem integrity and human well-being for the future.

- Countries are investing in water resources management programs and projects to address local
  flooding and drought risks, adapt to climate change, and improve the climate resilience of water
  and sanitation services. GCA provides technical assistance to International Financial Institution
  (IFI) financed projects to ensure that climate adaptation and resilience is incorporated in project
  technical designs. This support leads to improvements in climate resilience of water and sanitation
  systems and contributes to the long-term sustainability of access to water and sanitation services.
- Technical and institutional capacity building, along with financial support and partnerships is urgently needed to enhance the feasibility and effectiveness of climate adaptation solutions across physical, natural, and social infrastructure.1 GCA plans to contribute to capacity development efforts to ensure resilience of investments in water and sanitation services delivery. This will be done through a Climate-Resilient Water Services (CRWS) masterclass to build the capacity of government water sector officials, including water service providers in several countries in 2025, by collaborating with local institutions to ensure sustained expertise long after project implementation ends. The Climate-resilient Water Services masterclass will contribute to enhancing the capacity of national and local governments to accelerate and scale high-impact climate adaptation and resilience-building efforts in delivering water services. The CRWS masterclass seeks to continuously enhance capacity to promote a virtuous cycle of continuous reflection and improvement of tools, methods, and approaches. It will flexibly deploy targeted support through a suite of capacity building actions. This will enable the government water sector and other officials to address climate related challenges affecting the delivery of water and sanitation services under different climate scenarios. The CRWS masterclass will deliver practical knowledge relevant for climate resilient infrastructure planning and development, policy (i.e. legislation, regulation), climate resilient water utilities, and service delivery (both formal and informal) - serving the needs of diverse actors from all sectors (water resources, irrigation, fisheries, WASH), ensuring that capacity is built across these linked sectors in an integrated way.
- GCA is seeking a capacity building partner to deliver a Climate Resilience Masterclass for government officials in several African countries. GCA invites concept notes from partners with experience in delivering learning materials and facilitating training for public officials on climate resilience in water resources management, WASH, and other related disciplines in Africa. This learning program will focus on strengthening climate-resilient water services and will be delivered in at least seven countries.<sup>2</sup> The masterclass should be designed as a one week (five-day) intensive course in each country.

# 2.2. Project Objectives

- GCA's Climate-Resilient Water Services masterclass aims to address the challenges related to climate change and water resources management. GCA plans to partner with a qualified organization to develop and deliver a Climate-Resilient Water Services (CRWS) masterclass aimed at strengthening the capacity of government water sector officials and service providers in several African countries as part of its technical support to IFI-financed water and sanitation projects. The masterclass will deliver targeted learning materials and capacity building to ensure that climate adaptation and resilience are adequately considered in the design of water and sanitation investments. The CRWS masterclass will focus on:
  - Addressing the dual challenge of expanding and sustaining access to improved water services under a changing climate.
  - Enhancing the climate resilience of water services and sanitation services.

# 2.3. Project Deliverables

The project deliverables include:

2.3.1. Climate Resilient Water Services Masterclass handbook.

The Climate Resilient Water Services masterclass handbook will cover five modules, codeveloped with GCA and GCA partners. The five modules will cover topics including the following:

- Introduction to water resources climate resilience and adaptation concepts.
- Understanding climate risks and water services resilience in the local context.
- Integrating climate resilience in Integrated Water Resources Management.
- Climate resilience and adaptation for surface water and groundwater supply schemes.
- Step by step guidance for ensuring climate resilient water and sanitation services, considering specific gender climate vulnerability and necessary actions.
- Building Climate Resilience in Rural and Vulnerable Communities, including gender considerations.
- Technology and innovation monitoring (e.g. IoT, satellite data, etc.), predictive analytics and early warning systems, and circular economy (desalination, water reuse, and recycling).
- Step by step guidance for financing climate resilient water and sanitation services infrastructure.
- Climate adaptation options for enhancing climate resilience of water utilities.
- Effective incorporation of gender considerations in climate resilient water and sanitation services delivery.
- Financing climate-resilient water and sanitation infrastructure.
- Case studies and practical applications relevant for local environments.

# 2.3.2. Five Masterclass modules outlined (delivered in PowerPoint format), covering content including that outlined in section 2.3.1

# 2.3.3. Five-day masterclasses delivered in person to public service participants.

A five-day masterclass will be delivered by the partner organization in each of at least seven (7) countries in Africa.<sup>3</sup> The target audience will include junior, middle, and senior level public and water utility officials. GCA will work together with the partner organization to identify and finalize the masterclass participant list for each country. The masterclass will be delivered in English or French, depending on each country's language preference.

# 2.3.4. Masterclass delivery report for each masterclass delivered.

A masterclass workshop report will be outlined after each CRWS masterclass delivery. The report will be in English, for English-speaking countries, and French for French speaking countries. For Cameroon, the report will be prepared in English and French.

# 2.4. Alignment with GCA Values and Commitment & Experience in Partnership Engagement

- Demonstrated support of the core values of GCA and its commitment to climate action and adaptation.
- Active engagement in partnerships and initiatives with, inter alia, United Nations, intergovernmental, national, subnational, industry or sectoral, non-governmental and other related organizations in support of climate, environmental and/or social causes.

# 3. Submission Guidelines

# 3.1. How to Apply

 Only registered non-profit organizations (including local and international non-government organizations, community-based organizations), universities, and companies limited by guarantee are eligible to receive a sub-grant from GCA.

The organizations responding to this call must meet the minimum eligibility criteria and demonstrate their capacity to implement all the technical criteria.

- The concept note and all supporting documents must be submitted as a PDF, no later than 28th November 2024, 16:00 Central European Time (CET) to <u>subgrants@gca.org</u> and cc'd to <u>shaimaa.zakaria@gca.org</u>.
- The concept note **must include**:
  - o Annex 1: Concept note template addressing the details outlined in this call.
  - o Annex 2: Completed Partner Information Document & Minimum Required Documents.
- An information session with all organizations interested in applying and learning more about the application process and project requirements will take place on 22nd November 2024 at 14:00 CET. The meeting can be accessed on that day and time. The link for the meeting will be shared on request.

- All registered non-profit organizations (including local and international nongovernment organizations, community-based organizations), universities, and companies limited by guarantee are encouraged to respond to this call and complete the templates in as much detail as possible.
- Responses to Annex 1 will be considered even if there is a lack of detail or if the form is incomplete.
- Responses to Annex 2 will be considered even if some details are lacking, if justified.
   The template serves as a tool for interested organizations to showcase their technical expertise and experience in response to the call.
- Organizations need only meet the minimum eligibility criteria to be considered.
- Concept notes received after the closing date and time will not be considered. Organizations
  will be notified once a decision about the Sub-Grant is made.

- The concept notes and all supporting documents must be drafted in English.
- GCA reserves the right to decline disclosure of the specificity of decision derived by GCA mission due to reasons related to confidentiality.
- GCA reserves the right to accept or reject any submissions, and to annul the selection process and reject all submissions at any time, without thereby incurring any liability to the affected implementing partners.

#### 3.2. Process Overview

- After the deadline, all submissions will undergo an evaluation process.
- The most suitable partner will be selected based on the evaluation outcomes.
- The selected partner will be contacted to conduct a due diligence assessment through in-depth meetings.

# 4. Selection Criteria & Evaluation

The purpose of the evaluation is to assess the organization's eligibility, and the adequacy of the technical expertise of respondents. The evaluation consists of two sets of selection criteria:

- (1) Minimum Eligibility Criteria
- (2) Technical Expertise

The first section specifies the minimum eligibility criteria that an organization must meet to qualify for the call. This set of criteria is evaluated on a pass/fail basis. Only organizations that pass this initial assessment will proceed to the next stage.

The technical expertise is evaluated based on the relevance and depth of experience and expertise in relation to the criteria outlined in the call, specifically how well these align with achieving the expected results.

# 4.2. Exclusionary Criteria

GCA will not engage with any entity whose public image is severely compromised by past activity or advocacy in one of the categories below, or in other areas which may be deemed, at any given time, to reflect negatively on GCA. GCA will not engage with institutions on the list of ineligible firms to provide services to any international financing institution (for example the World Bank Group, African Development Bank, etc.) or other GCA partner.

# 4.3. Evaluation

After assessing whether organizations meet the minimum eligibility criteria, the organization with the highest score in the technical evaluation will be considered for the sub-grant. The scoring allows GCA to identify the most suitable partner.

A preliminary capacity assessment will be conducted based on the information provided in Annex 2. This assessment aims to identify organizational and programmatic risks and will not impact the evaluation scoring or partner selection. The insights gained from this assessment will inform the comprehensive due diligence assessment that the selected partner will undergo.
